I HEREBY CONFIRM AS FOLLOWS / NGIYAVUMA NJENGOBA KUBONISWE NGEZANSI:

- I previously submitted to the Fund an application for a disability retirement benefit.
Ngokwedulele ngithumele isicelo senzuzo yokuthatha umhlala phansi ngenxa yokukhubazeka Esikhwameni Soxhaso.
- To qualify, I am required to prove to the Fund's Board that I am totally and permanently disabled for my own and similar occupation in a specific environment.
Ukuze ngifaneleke, kudingeka nginikeze ubufakazi Ebhodini Lesikhwama Soxhaso ukuthi nginokukhubazeka okungumahlala khona nokuphelele nokuthi nginomsebenzi ofanayo endaweni ethile.
- I have been informed that:
Ngazisiwe ngokuthi:
 - The Board's Claims Committee is not satisfied I have proved I meet the criteria in 2 above;
Ikomiti Lebhodi Yezicelo aligculisekile ngokuthi ngikufakazele ukuthi ngiyahlangabezana nezici ezingu-2 ezingenhla;
 - The Committee will reconsider my application if I submit new functional medical evidence. This is subject to timeperiods specified in the Fund's Rules.
Ikomiti lizocabangela isicelo sami uma ngiphinde ngithumela ubufakazi obusha obusebenzayo bezokwelapha. Lokhu kuzosekelwa ohlelweni lwezikhathi ezichazwe Emithethweni Yesikhwama Soxhaso.
- I know that after leaving the service of a participating employer, I can elect the alternative option to claim a termination benefit or early retirement benefit from the Fund.

- I have elected to claim a termination / retirement* benefit.

- I have been informed that:
Ngazisiwe ngokuthi:
 - A termination benefit / early retirement benefit does not include the disability cover which is included in an inservice disability benefit. It comprises my fund credit only;
Inzuzo yokuyekiswa / inzuzo yokuthatha umhlalaphansi ngaphambi kwesikhathi ayihlanganisi umshwalense wokukhubazeka ohlanganiswe enzuzweni yokukhubazeka ngesikhathi usasebenza. Ihlanganisa imali yami esesikhwameni kuphela;
 - A termination benefit is payable as a once off lump sum. An early retirement benefit is payable as a monthly pension with a maximum commutation of one-third (subject to certain exceptions which may not apply to me);

- c. I cannot receive a termination benefit / early retirement benefit and a disability benefit from the Fund for the same service period;
Angikwazi ukuthola inzuzo yokuyekiswa / inzuzo yokuthatha umhlala phansi ngaphambi kwesikhathi kanye nenzuzo yokukhubazeka evela Esikhwameni Soxhaso senkathi efanayo yokusebenza;
- d. Once the Fund puts my election into effect:
Lapho Isikhwama Soxhaso sesikusebenzisa lokho engikukhethile:
- i. I cannot revoke it or change my mind;
Ngeke ngikwazi ukukwenqaba noma ngishintshe umqondo;
- ii. I will have no claim to any other benefit from the Fund for the same service period, including a disability benefit (or part of a disability benefit);
Ngeke ngibe nesicelo kunoma iyiphi enye inzuzo Yesikhwama Soxhaso senkathi efanayo yomsebenzi, okuhlanganisa inzuzo yokukhubazeka (noma ingxenye yenzuzo yokukhubazeka);
- e. Once a termination benefit is paid or transferred, no benefit will be payable by the Fund on my death as is the case with a retirement benefit;
Lapho inzuzo yokuyekiswa isikhokhiwe noma isithunyelwe, ayikho inzuzo ezokhokhelwa Isikhwama Soxhaso uma ngifa njengoba kunjalo nangenzuzo yokuthatha umhlala phansi ngaphambi kwesikhathi;
- f. A termination withdrawal benefit is generally taxed differently to a retirement benefit.
Ukukhipha imali yenzuzo yokuyekiswa ngokuvamile ikhokhelwa intela ngendlela ehlukile enzuzweni yokuthatha umhlalaphansi ngaphambi kwesikhathi.
7. I also acknowledge that by electing this option and signing this document:
Ngiphinde ngiyavuma ukuthi ngokukhetha le nketho nangokusayina le dokhumenti:
- a. I waive any right to claim that I was not informed of the consequences of my election;
Ngiyeka noma iliphi ilungelo lokufaka isikhalo sokuthi angizange ngitshelwe ngemiphumela yokukhetha kwami;
- b. I will have no basis to dispute the decision of the Committee as per 3a above through the courts, the Pension Funds Adjudicator or any other forum, or to seek an order that the Fund must award me a disability benefit for the same service period;
